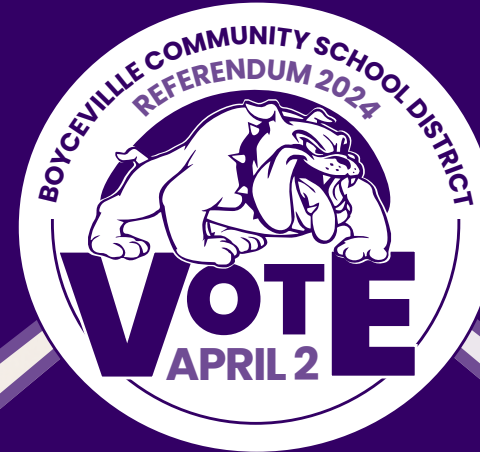

Message to the Boyceville Community from the District Administrator

As an integral part of our vibrant community, we are reaching out to share crucial information about an upcoming initiative that will significantly impact the future of our local educational facilities.

In early 2023, an in-depth on-site audit was conducted in Tiffany Creek Elementary School, Boyceville Middle/High School, and the bus garage within our school district. The audit assessed the current state of these facilities and developed a comprehensive maintenance and capital project plan focused on safety and infrastructure concerns.

Based on the audit findings, it has become evident that essential improvements are needed to ensure the safety, functionality, and overall quality of our educational spaces.

To address these needs, we are pursuing an **\$18 million school facilities referendum** to be presented to the community for approval. The District is dedicated to ensure our educational facilities meet the standards to provide students with a safe and conducive learning environment.

We invite you to attend informational sessions held in the coming weeks to learn more about the proposed referendum, ask questions, and engage in open discussions. Your input is invaluable, and we want to ensure that the community is well-informed and actively involved in the decision-making process.

Together, we can significantly and positively impact the future of our local schools. We look forward to your participation and support in this important endeavor.

Proposed Upgrades

The referendum will address maintenance needs that have grown over the years, exceeding the District's standard operating budget. Completing the improvements below will collectively aim to enhance the overall infrastructure, safety, and functionality of the District's buildings.



- #### Tiffany Creek Elementary School
- Implementing security and safety enhancements.
 - Updating key infrastructure, including HVAC and lighting systems.
 - Renovating specific areas, such as restrooms, by updating partitions and painting to improve facilities.
 - Enhancing building aesthetics and functionality for a more conducive learning environment.



- #### Boyceville Middle/High School
- Upgrading building security.
 - Improving aesthetics and functionality of entrances and exteriors.
 - Addressing specific facility issues related to flooring, single-pane windows, and plumbing in classrooms.
 - Enhancing lighting and technology infrastructure.
 - Refreshing vital systems like ventilation, flooring, and communication.

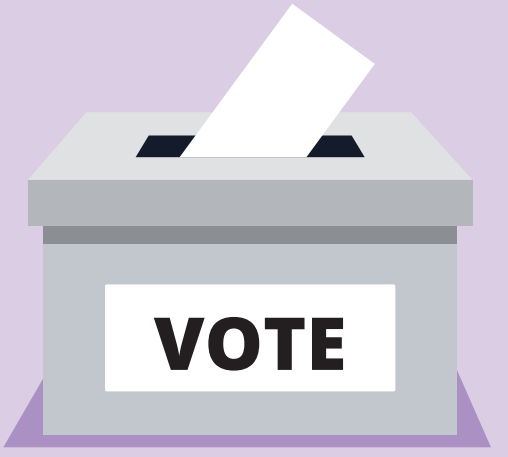
- #### Boyceville Bus Garage
- Acquiring new buses and vans.
 - Updating the shop facilities.
 - Installing a new lift.
 - Updating shop ventilation.
 - Implementing LED upgrades.

What's on the ballot?

\$18 Million Capital Referendum

BE IT RESOLVED by the School Board of the Boyceville Community School District, Dunn, St. Croix, and Barron Counties, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed **\$18,000,000** for the public purpose of paying the cost of a school facility improvement project consisting of:

- ✓ *District-wide building systems.*
- ✓ *Infrastructure and capital maintenance improvements.*
- ✓ *Remodeling, safety, security, and site improvements at the Elementary and Middle/High Schools.*
- ✓ *Technology updates.*
- ✓ *Improvements to the bus garage.*
- ✓ *Acquisition of furnishings, fixtures, and equipment, including school buses/vehicles.*



Tax Impact

If the **\$18 million** question is approved, there will be no increase over current mill rate for referendum approved debt. Visit the District's referendum webpage for assumptions regarding the financing plan.
